> As New Zealand's electricity System Operator, Transpower is responsible for keeping the lights on 24 hours a day, seven days a week. Over the past few years, weather and gas supply challenges have highlighted the sensitivity of renewable generation to service winter demand and had the system operator working hard. With more intermittent renewable generation in the pipeline, what is the outlook for our energy security? And what is the process of balancing supply with demand and what is the escalation pathway when there is a shortfall? This overview of energy security and look at the fundamentals of system balance will provide everyone with a clearer understanding of the challenges ahead and intervention available.

2.10pm Multiple Trading Relationships (MTR) pilot update

> Minister of Energy and Resources Megan Woods says MTR could introduce more competition into the electricity sector, making electricity cheaper for customers, helping reduce energy hardship and enabling greater uptake of low-emission technologies, such as solar.

With the support of the Electricity Authority, New Zealand's future energy centre, Ara Ake, has started a world-first pilot that allows customers to contract with more than one electricity supplier at a single location.
